The Miller Grove School Board met in a Regular session with the following members present:

The meeting was called to order at 6:00 p.m.

Approve previous meeting minutes:

A motion was made by Lewis Russell and seconded by Jim Potts to approve the minutes of the January 21, 2013 meeting. The motion carried unanimously.

Payment of the bills:

A motion was made by Jim Potts and seconded by Doug Hall to pay the bills. The motion carried unanimously.

Track Update:

Clint George provided a short video of the construction of the Harts Bluff track.

Taxing Personal Vehicles:

A motion was made by Jim Potts and seconded by Doug Hall to NOT tax personal vehicles in Rains County. The motion carried unanimously.

School Safety:

A motion was made Lewis Russell and seconded by Doug Hall to raise Mrs. Fox's wages to \$50,000 and give her a one year regular contract. The motion carried unanimously.

A motion was made by Lewis Russell and seconded by Kristi Burnett to accept the resignation of Corey Jenkins at the end of the current contract year. The motion carried unanimously.

Administrative Reports:

Superintendent—Mr. Johnson advised the Board that a parent had called and wanted the school to take any steps necessary to safeguard the school and students.

Mr. Johnson advised the Board that Patti Lennon had announced her retirement effective at the end of the current school year.

Principal's Reports:

Mrs. Irby reported on up-coming events and that secondary enrollment was 116.
