- Bo Fox asked if first aid and stop the bleed kits were available during these times. Dr Rakin said that all rooms have “GO” bags that have all the first aid and stop the bleed in them. In the event of a safety issue the teacher takes the go bag with them so that they have all the needed supplies. They also have them in their rooms at all times if they are needed there.
- Bill Alberts asked if we had AED’s the district. Dr. Rankin and Mrs. Fox spoke about where they are all located throughout our district.
- Brandon Darrow asked about the playground fence. Dr. Rankin said that in November they are going to be installing a shadow box fence all around it. There is currently a chain link fence and the students are all visible when at recess. The shadow box fence will allow air to get in and some sight but very limited.
